

Author Addendum Instructions

- 1) Download the PDF document "Addendum to Publication Agreement" below.
- 2) Fill out the form and digitally sign and date it. [Or fill it out, print it, and sign and date it manually.]
- 3) Sign and date the publisher's agreement. Immediately below your signature on the publisher's agreement, write, "Subject to attached Addendum." [If your publisher uses a web-based form for their publication agreement, print out the web page and write: "Subject to attached Addendum."]
- 4) Make copies of both the publisher's form [or web page] and the addendum for your records.
- 5) Email or mail both documents to the publisher.
- 6) If you receive a signed copy of the addendum back from the publisher, please send a copy to <insert link: OAP email? Or scholcomm?> or mail it to:

ADDENDUM TO PUBLICATION AGREEMENT

1. This Addendum modifies and supplements the attached publication agreement (the "Publication Agreement") concerning the following article (including any supplementary materials, the "Work"):

2. The parties to the Publication Agreement as modified and supplemented by this Addendum are:

3. The parties agree that wherever there is any conflict between this Addendum and the Publication Agreement, the provisions of this Addendum will control and the Publication Agreement will be construed accordingly.

4. Notwithstanding any terms in the Publication Agreement to the contrary, Author and Publisher agree as follows:

a. All of the terms and conditions of the Publication Agreement, including but not limited to all grants, agreements, representations, and warranties, are subject to and qualified by a non-exclusive license previously granted by Author to the University at Albany. Under that license, the University at Albany may make the Work available and may exercise all rights under copyright relating to the Work, and may authorize others to do the same, provided that the Work is not sold. In the exercise of that license, the University at Albany may use the Author's final manuscript of the Work (including all modifications from the peer review process), but will not use a facsimile of the final published version of the Work unless Publisher permits use of that version. When the University at Albany makes the Work available in an online repository under that license, the University at Albany will cite to Publisher's definitive version of the Work, and will link to Publisher's version of it if it is available online.

b. Where applicable, Publisher acknowledges that Author's assignment of copyright or Author's grant of exclusive rights in the Publication Agreement is subject to Author's prior grant of a nonexclusive copyright license to Author's employing institution and/or to a funding entity that financially supported the research reflected in the Article as part of an agreement between Author or Author's employing institution and such funding entity, such as an agency of the United States government.

c. Nothing in the Publication Agreement will impose any limitation on the rights and licenses referred to in the paragraphs above or any obligation in connection with their exercise. Neither the existence nor the exercise of those rights and licenses will be deemed to violate any representation or warranty or to breach the Publication Agreement.

5. Either publication of the Work or Publisher's signature below will constitute Publisher's acceptance of and agreement to this Addendum.
