Maurice Hinchey (born 1938) served in the New York State Assembly from 1975 until 1992 and then in the United States Congress from 1993 until his retirement in 2013. He first represented the 26th

Congressional district of New York and then the 22nd after redistricting. Both are in the Hudson Valley. Hinchey is a member of the Democratic Party.
