Dr. Margaret Vandiver is retired from the Department of Criminology and Criminal Justice at the University of Memphis. Dr. Vandiver's main area of research interest is state and collective violence, ranging from the use of the death penalty in the United States to contemporary instances of genocide. She is the author of *Lethal Punishment: Lynchings and Legal Executions in the South* (2006), co-author with

Michael Radelet of Capital punishment in America: an annotated bibliography (1988), and co-editor of Tennessee's New Abolitionists (2010), in addition to numerous articles. In retirement, she continues to speak and research historical homicides and death penalty cases.
